At the request of the Barvalipe Chair, ERIAC management will present the statutory rules relation to Barvalipe mandate and membership.

The management informed that according to Statute paragraph 8.2:

The members of the Academy are appointed by the permanent members of the association as provided for in § 11 (seven members of the Academy to be appointed jointly) and the General Assembly in accordance with § 13 (eight members of the Academy) for a term of office of three years; re-appointment is possible once."

The Board will discuss the reappointments of the first 7 members during their meeting in 2021.

The Barvalipe Members appointed by the General Assembly have their term running from December 17 2018 – December 17 2021. The General Assembly will discuss and take decisions regarding re-appointments during the General Assembly meeting to be hosted in December 2021.

The Chair dr. Bogdan thank all present members for their attendance and closed the meeting at 18.10.
